

WE ARE IMPROVING EQUINE DNA ANALYSIS!

In 2022 Horse Sport Ireland (HSI) announced the Microsatellite (MS) to Single Nucleotide Polymorphism (SNP) DNA transition scheme. This scheme is funded by the Department of Agriculture, Food and the Marine under National Breeding Services and Equine Technical Support funding.

Phase I of the transition saw an invitation to all Department of Agriculture, Food, and the Marine (DAFM) sport horse studbooks to participate in the scheme, funded under National Breeding Services operated by Horse Sport Ireland (HSI). Participating sport horse studbooks were allocated several SNP tests to generate a 'reference library' of their active breeding herd.

To date, The Connemara Pony Breeders Society, Kerry Bog Pony Co-operative, Irish Harness Racing Association, Leisure Horse Ireland and HSI studbooks (Irish Sport Horse, Irish Sport Pony, Irish Draught, Irish Cob, and Irish Part bred Cob studbooks) have re-analysed almost 10,000 mares and stallions on the SNP technology. This re-sampled population provides the basis for phase II of the project, implementing SNP parentage verification for the 2023 sport horse foal crop. In 2023 the Warmblood Studbook of Ireland (WSI) will also be engaged in this scheme.

This is a hugely significant move for the sport horse sector in Ireland; ovine and bovine parentage testing moved from MS to SNP testing in 2009. Equines are the only remaining species using MS for parentage verification. This transition provides Irish breeders with the opportunity to become world leaders in equine genetics, joining the KWPN and German Studbooks.

There are significant advantages to using the SNP technology in horses such as improved accuracy of pedigree, preservation of rare lines, monitoring health related genes and potential abnormalities, predicting coat colour and, in time, research on other breeding and performance related traits.

What does this change look like for Irish breeders?

Breeders may receive multiple hair sample bags for submission to their studbook during foal registration – this is normal!

You will still need your vet to mark, and hair sample your foals.

To generate a reliable SNP profile for the foal, it is essential to have the SNP genetic profiles of both parents of the animal. In some cases, only one parent will be SNP technology. This will require sire/dam AND foal hair samples for SNP typing. See our graphic below outlining when an MS test is required.

ALL HAIR SAMPLES MUST BE RETURNED TO THE PASSPORT ISSUING ORGANISATION (PIO) AND NOT THE LABORATORY.

Please ensure to submit all hair samples as directed in your foal kit.

The Veterinary Council of Ireland and Irish Equine Veterinary Association have been notified of this transition, the potential for multiple sample bags and to return hair sample bags to the PIO.

What kind of sample is required?


Good hair sampling is imperative for a successful transition. A minimum of 50 clean, intact hairs pulled from the root must be submitted to the PIO for SNP sampling. These hairs must have the follicle/hair blub intact. Please ensure there is no soap or other residue on these hairs.


What is the cost?


There is no cost to the breeder for SNP testing of the sire, dam or foal. Dam/Sire SNP testing is supported by the DAFM-HSI National Breeding Services at 100%.


Foal SNP typing is supported by the DAFM Equine Technical Support fund at 70%, the other 30% is included in the studbook registration fee.

MS technology is no longer supported by the DAFM and participating sport horse studbooks. If a breeder requires a MS test, they will be required to cover the laboratory cost of approximately €31.50 to the registering studbook. It is important that stallion SNP samples are submitted if requested to prevent this cost to the breeder. If you have already received a request for your stallion hair sample, please return this to the registering studbook as soon as possible.











How do I know if my mare/stallion was included in the reference library?

It is not possible for any PIO to predict all potential breeding stallions and mares in the reference library. If you are breeding this year and would like to ensure your stallion/mare is on the SNP technology, please fill out the contact form via the Breeder 'G' Checker button below. If they are not included in the reference library, the studbook will issue the required sample bags

Many PIOs are working to upgrade their websites to offer an online 'G' (SNP genotype) checker function. This will remove the need to request information as you will be able to check this online.

I am breeding from a non-pregnant OR maiden mare; will she be on SNP?

She may be on the platform if she has foaled in the previous three years OR engaged in previous National Breeding Service schemes. Please fill out our contact form via the Breeder 'G' Checker button below to make a request. If they are not included in the reference library, the studbook will issue the required sample bags.

I am a stallion owner/agent, what do I do?

If you are a stallion owner or agent, you are obliged to ensure that your stallion meets the DNA testing requirements of the studbooks for which the progeny is to be entered. DAFM has declared that SNP is the DNA platform to be applied by the sport horse sector in Ireland.

Please check IHR online by searching the equine in question. If only MS is entered in the DNA section, then the horse is not in the reference library. Please contact the studbook and they will issue the required sample bags.

This is particularly important for stallions standing abroad, where a hair or semen sample may be required to prevent the additional MS testing cost to breeders who are expecting 2023 foals.

Social License to Operate – Why it matters to the horse industry in N1.

What do we mean by "Social License to Operate"?

Social license to operate first arose in 1997 in the mining industry since then it has become more relevant across a range of industries including farms, zoos, circuses and more recently to the equestrian world. "A social license is said to exist when an industry or activity has the ongoing acceptance or approval of society, and it allows that industry to operate with minimal restriction" (Douglas et al, 2022).



The legal right to operate is granted by legislation and government, whereas the social license to operate is an implied agreement between the public or its stakeholders and those who engage in the activity. However, if the public rejects an activity it is possible for legislation to follow. One such example being the ban on hunting.

Social license to operate is an increasingly important concept in the horse industry. It refers to the level of acceptance and support that a horse business or organisation has among its stakeholders, including the public, customers, employees, local communities, and regulatory agencies. This social license is essential to the sustainability and success of any equine operation, as it establishes trust, transparency, and accountability in all its activities.



Why should we as horse owners be mindful of the social license to operate?

One of the main reasons why equine social license to operate has gained prominence is the growing awareness of animal welfare and environmental concerns. Horse businesses are expected to operate in a transparent, responsible, and ethical manner, ensuring the well-being of their animals and minimising their impact on the environment. No part of the horse industry is exempt from the power that can be exerted by its social license. If one part of the industry brings equestrianism into disrepute it could be very difficult for the whole industry to recover. We must therefore be aware of and value our equine social license to operate and ensure that there are ways to measure these standards and to communicate them to the public.

How can equestrians protect the social license to operate?

To achieve equine social license, all horse owners, equestrian businesses, and stakeholder need to engage in a variety of activities that demonstrate their commitment to social responsibility.

These activities may include:

- 1. Developing and implementing animal welfare policies that align with industry standards and best practices.
- 2. Conducting regular audits and inspections to ensure compliance with animal welfare, safety, and environmental regulations.
- 3. Providing training and education to staff, customers, and stakeholders on proper horse care, handling, and management.
- 4. Participating in community events and initiatives that promote equine welfare, environmental stewardship, and sustainable development.
- 5. Openly communicating about the industry's activities, values, and impacts, including its challenges and opportunities.

Equine social license to operate is not just a matter of good public relations or marketing. It is a fundamental shift in the way horse businesses operate, recognising that their success depends on the health and well-being of their animals, their employees, and their communities. By earning and maintaining social license, horse businesses must build trust and credibility with their stakeholders, reducing the risk of negative publicity, backlash, and legal action.

In conclusion, equine social license to operate is a critical concept for any horse business or organisation that seeks to thrive today. By adopting a socially responsible approach to their activities, horse businesses can develop strong relationships with their stakeholders, establish themselves as leaders in their industry, and contribute to a better future for horses and humans alike. Whether you are a horse owner, a trainer, a breeder, or a competition organiser, it is in your best interest to embrace equine social license to operate as a core foundation for your operation.

Dassett Arthalent was bred out of a Nigrasine mare, Timpany Night, an event mare which we bought from Davy Lyons and was successfully evented by Clare Abbott until she was injured in the field. We decided to breed from her while she recovered and we chose Valent, Rosbotham's stallion to cover her, on advice from sour friend Caroline Berry. Valent is a lovely correct horse with scope to burn and a fabulous temperament, all of which he passed on to Arthur.



Arthur had bags of character and presence as a foal, full of confidence and easy to handle. We broke him in his 3-4 years, totally trouble free, always beautifully balanced and easily trained. He was riding in no time at all. From 4year old he did a little show jumping and started to Event in his 5 year old year. He loved his Eventing job and progressed very quickly winning at National and International level.

Piggy March was told about Arthur, she came over and tried him and he went to his new home in England in October 2021. The decision to sell him was helped by knowing the calibre of rider he was getting. He went on with Piggy to win National Events, 2* and 3* International Events and the 7year old British Championships.

In October 2022 Arthur went to the Young Horse World Championships in France where he went foot perfect and won the Silver Medal for 7 year old horses. Piggy is very good at keeping us up to date with his progress and we look forward to further success in the future.

HORSE SPORT IRELAND LAUNCH 2023 BREEDING INITIATIVES

This year, HSI is delighted to introduce several new innovative schemes:

- Premium Mare Retention Scheme
- Colt Retention Scheme
- A graded Schooling Scheme (I & II)
- Environmental Research Report
- Environmental Sampling with the Irish Equine Centre
- ICSI* under the Embryo Transfer Scheme

Horse Sport Ireland (HSI) is delighted to launch its breeding initiatives for 2023 and open schemes for applications.

These schemes are funded by the Department of Agriculture, Food and the Marine (DAFM) through National Breeding Services to the tune of almost €2.9 million, with additional production classes and events to be launched in the autumn.

Through several schemes, the Department of Agriculture, Food & Marine, and equestrian governing body HSI have collaborated to ensure monetary backing for Irish breeders across the country, in all DAFM-approved Studbooks and Irish-bred studbook registered horses.

Funding for existing schemes has been made available and Irish studbook breeders nationwide are encouraged to apply for grants such as;

- Breeding Grant Sponsorships
- Young breeder programme
- SNP transition Scheme
- Mare Upgrade Scheme
- Mare X-ray Screening Scheme
- Starting scheme (formerly breaking)
- Schooling Scheme
- Embryo Transfer Scheme*
- Stallion X-ray Scheme



Availing of this year's initiatives and schemes - funded by the DAFM and administered by HSI - will help equine breeders to grow their operation and ensure they have the best possible opportunity to make successful breeding decisions, helping them to boost sales and increase potential for elite performance.



Update NORTHERN IRELAND
















With Atypical Myopathy (Sycamore Poisioning)cases on the rise in Spring and Autumn months, heres a few details in what to look out for in your paddocks.

WHAT IS ATYPICAL MYOPATHY?



Atypical myopathy (sycamore myopathy) is a severe and often fatal muscle disorder caused by ingesting sycamore seeds, leaves or seedlings.



DIAGNOSIS & TREATMENT

Vets consider the horse's environment as well as symptoms reported and those observed during an examination.

CLINICAL SIGNS



General weakness: horses struggle to walk, stand and breathe

Many horses develop heart problems.

Horses appear depressed with low hanging heads

Muscle trembling

Signs of severe colic - yet, unlike colic, they still have an appetite

Brown or dark red urine

Severely affected horses become unable to stand



As confirmation can take several days, vets often start treatment immediately and before official confirmation. Your horse may require admission to a specialist equine hospital for 24 hour advanced care. If horses survive the first few days of treatment they usually go on to recover completely, although this can take several months.

PASTURE MANAGEMENT

The following steps can be taken to reduce horses' risk to atypical myopathy

- -Provide extra forage during Autumn
- -Clear fallen leaves and seeds from fields
- -Check neighbouring areas for high risk plants/seeds as some 'helicopter' seeds can travel up to 200 yards
